- The RSUs will vest 100% if the reporting person remains continuously employed with the issuer through April 10, 2026 and will be paid as soon as administratively practical thereafter.
- At the direction of the issuer's Compensation Committee, the RSUs may be paid in shares of HOFT common stock, cash (based on the fair market value of a share of HOFT common stock on the date payment is made) or both.
- On April 7, 2020, the reporting person was granted 4,310 restricted stock units, vesting 100% on April 7, 2023 as the reporting person remained continuously employed with the issuer through that date.
